## HKMA launches Project Ensemble Sandbox to accelerate adoption of tokenisation

The Hong Kong Monetary Authority (HKMA) hosted on August 28 the launch ceremony

for Project Ensemble Sandbox (the Sandbox) and introduced four main themes of asset tokenisation use cases for the initial round of experimentation, marking a significant step forward in the advancement of tokenisation in real-world application within the financial sector.

The Sandbox is designed to facilitate interbank settlement using experimental tokenised money, focusing on transactions involving tokenised assets. The initial round of experimentation will cover tokenisation of both traditional financial assets and real-world assets, focusing on four main themes: fixed income and investment funds, liquidity management, green and sustainable finance, and trade and supply chain finance.

On the international front, the HKMA will also explore collaborating with the Bank for International Settlements Innovation Hub Hong Kong Centre across one or more themes, and engage the central bank digital currency (CBDC) Expert Group to leverage their subject matter expertise to further advance the Sandbox.

## Government launches new batch of Silver Bond

The Hong Kong Special Administrative Region (HKSAR) Government announced on September 10 the launch of a new batch of Silver Bond for subscription by eligible Hong Kong residents.

The target issuance size of the Silver Bond is HK\$50 billion, with each unit offered at HK\$10,000 and a tenor of three years. Interest will be paid semi-annually at a rate linked to inflation in Hong Kong, subject to a minimum of 4 per cent. Hong Kong residents who turn 60 in or before 2025 holding a valid Hong Kong identity card will be eligible for subscription.

The bonds are the retail part of the Infrastructure Bond Programme. Proceeds will be credited to the Capital Works Reserve Fund for investment in infrastructure projects in accordance with the Programme framework. The Government will publish information on the allocation of the proceeds on an annual basis.

The subscription period of the Silver Bond will start from 9am on September 30 and end at 2pm on October 14 (Hong Kong time). The bonds will be issued on October 23. Eligible Hong Kong residents may apply for the bonds through one of the placing banks and designated securities brokers. For details, please visit <u>www.hkgb.gov.hk</u>.

# CE congratulates Hong Kong, China Delegation on remarkable achievements at Paris Paralympics

The Chief Executive of the HKSAR, Mr John Lee, on September 8 expressed his congratulations to the Hong Kong, China Delegation on its outstanding achievements at the 2024 Paris Paralympic Games. He praised the athletes for giving their utmost in the competitions, and showcasing to the world the indomitable Hong Kong spirit and the extraordinary capabilities of Hong Kong athletes with disabilities.

The Hong Kong, China Delegation captured three gold medals, four silver medals and one bronze medal in this year's Paralympic Games.

Mr Lee remarked that the HKSAR Government fully supports the development of sports for persons with disabilities, noting that the estimated expenditure for the purpose amounts to over HK\$130 million in the current financial year, representing a growth of over 40 per cent compared to that of five years ago.

## Hong Kong students triumph at 36th International Olympiad in Informatics

A team of four students representing Hong Kong achieved excellent results in the International Olympiad in Informatics (IOI) 2024, winning one gold medal, two silver medals and one honourable mention. Representatives from 96 countries or regions from all over the world participated in this year's IOI, which was the 36th event and was held in Egypt.

The IOI under the United Nations Educational, Scientific and Cultural Organization is for secondary school students under the age of 20. It aims to promote coding education, nurture students' computational thinking and problem-solving skills, and is the most recognised worldwide computer science competition for secondary school students.

## Immigration Department implements Advance Passenger Information System

The Immigration Department (ImmD) of the HKSAR Government announced that the Advance Passenger Information (API) System was implemented on September 3.

To meet the aviation security requirements set by the Convention on International Civil Aviation and align Hong Kong with other aviation hubs worldwide, the ImmD has implemented the API System which requires aircraft operators to comply with the Immigration (Advance Passenger Information) Regulation (Cap. 115Q) by transmitting advance information about flights and passengers arriving in Hong Kong. This measure aims to enhance passenger clearance and ImmD's enforcement capabilities.

During check-in for a flight heading to Hong Kong, the aircraft operator will capture the required API data from a traveller's travel document and transmit the API data of each traveller and the aircraft information to the API System, which will instantly process the information and provide a response message. The aircraft operator shall act upon the direction given through the API System to allow or not allow specific travellers to board the aircraft heading to Hong Kong.

## **Recruitment of non-locally trained dentists**

Following the passage of the Dentists Registration (Amendment) Bill 2024 by the Legislative Council, the Department of Health (DH) of the HKSAR formally commenced the recruitment of non-locally trained dentists.

With the phased implementation of the amended provisions starting from 2025, qualified non-locally trained dentists will be allowed to practise in Hong Kong. Dentists who are interested in practising in Hong Kong and granted a conditional offer after the interview may submit a limited registration or special registration application to the Dental Council of Hong Kong, and upon approval directly practise at the DH.
