#### Hong Kong ranks as the world's freest economy

The Fraser Institute published the Economic Freedom of the World 2024 Annual Report (2024 Report) on October 16. Hong Kong ranks as the world's freest economies among

165 economies, up by one place from last year. Among the five areas of assessment in the 2024 Report, Hong Kong ranks top in "Freedom to trade internationally" and "Regulation", and its ranking in "Sound money" rises to third globally.

A spokesman for the HKSAR Government noted that Hong Kong for long has fully leveraged the advantages of a free market, and maintained a free, open, effective and fair business environment. The ranking fully reflects the international recognition of these advantages. Over 9 000 overseas and Mainland companies have chosen Hong Kong as their base to fully leverage Hong Kong's roles and functions as a "super connector" and a "super value-adder". The current-term HKSAR Government has been proactively attracting enterprises to settle in Hong Kong and talent to come to Hong Kong for development, and the response has been overwhelmingly positive.

In terms of attracting talent, from the end of 2022 to September this year, over 380 000 applications were received under various talent schemes, of which nearly 240 000 were approved, and around 160 000 people have arrived in Hong Kong. These figures underscore Hong Kong's strong appeal to both overseas and Mainland enterprises and talent.

## Policy Address: Reform for Enhancing Development and Building Our Future **Together**

The Chief Executive of the HKSAR, Mr John Lee, on October 16 announced his third Policy Address entitled "Reform for Enhancing Development and Building Our Future Together", setting out a range of initiatives to create new impetus for economic development, improve people's livelihood and enhance their quality of life.

The key initiatives of the Policy Address are summarized in six sections, including:

- 1) Consolidate and enhance Hong Kong's status as an international financial, shipping and trade centre
- 2) Develop new quality productive forces tailored to local conditions
- 3) Build Hong Kong into an international hub for high-calibre talents
- 4) Promote integrated development of culture, sports and tourism and foster economic diversification
- 5) Take forward the Northern Metropolis as growth engine and deepen GBA collaboration
- 6) Improve people's livelihood in pursuit of happiness

One of the highlights is a notable announcement regarding the New Capital Investment Entrant Scheme (New CIES). Effective from October 16, 2024, applicants under the New CIES are allowed to invest in residential properties, provided that the transaction price of a single property must be HK\$50 million or above. The total investment amount in real

estate (the aggregate of all residential and non-residential properties) is subject to an aggregate cap of HK\$10 million.

In addition, the HKSAR Government will reduce the duty on liquor with an alcoholic strength of more than 30 per cent (liquor) by introducing a two-tier system with different duty rates for each tier. Effective from October 16, the duty for liquor with import price over HK\$200 will decrease from 100 per cent to 10 per cent for the portion above HK\$200. The existing duty rate will remain for the portion of HK\$200 and below, applicable to liquor of up to one litre.

Mr Lee remarked that this Policy Address presents enhanced measures to boost the economy and improve people's livelihood. It also seeks to address the prevailing needs of the Hong Kong people, while mapping Hong Kong's vision and long-term goals for building a brighter future for Hong Kong.

# Strategic collaboration established to enhance Hong Kong's family office ecosystem

The Financial Services and the Treasury Bureau (FSTB) of the HKSAR Government announced on October 9 the establishment of Hong Kong Family Office Nexus, a strategic collaboration between the FSTB and Bloomberg L.P. (Bloomberg) with the goal of attracting family offices from around the world to establish or expand their presence in Hong Kong, and reinforcing the city's status as a leading global asset and wealth management hub.

The partnership with Bloomberg and Bloomberg Philanthropies, Mr Michael Bloomberg, will focus on four key pillars, namely community building, knowledge sharing, technology support and philanthropic collaboration. The FSTB, together with InvestHK and the Hong Kong Academy for Wealth Legacy, will collaborate with Bloomberg on various initiatives to bolster Hong Kong's family office ecosystem.

In addition, Bloomberg will introduce a new summit in Hong Kong focused on wealth management in March 2025. This event will complement and amplify the impact of the FSTB's annual flagship event, the Wealth for Good in Hong Kong Summit (WGHK). #### FS attends APEC Finance Ministers' Meeting in Peru

The Financial Secretary of the HKSAR, Mr Paul Chan, attended the Asia-Pacific Economic Cooperation (APEC) Finance Ministers' Meeting (FMM) and related activities in Lima, Peru, from October 20 to 21.

This year's APEC FMM takes the theme of "Sustainable + Digital + Resilient = APEC". During various discussion sessions, Mr Chan spoke on topics including global and regional economic and financial outlooks, sustainable finance, sustainable infrastructure, digital finance, and enhancing resilience against climate change.

Mr Chan specifically shared Hong Kong's experience in issuing retail bonds to support infrastructure projects that benefit the economy and people's lives. He also shared Hong Kong's progress in promoting the digitalisation of financial services, as well as Hong Kong's firm support for rules-based free trade and multilateralism.

# Hong Kong's first Chinese medicine hospital officially named "The Chinese Medicine Hospital of Hong Kong"

The HKSAR Government announced on October 9 the official naming of Hong Kong's first Chinese medicine hospital as "The Chinese Medicine Hospital of Hong Kong" (CMHHK) and launched the hospital's logo at the same time. The Secretary for Health of the HKSAR Government, Professor Lo Chung-mau, said that the establishment of the CMHHK marks a milestone in the city's commitment to driving Chinese medicine (CM) development. The Government is actively progressing with various preparations for the commissioning of the CMHHK, aiming to commence services in phases starting from the end of next year.

The CMHHK will focus on providing pure CM, CM-predominant and integrated Chinese-Western medicine clinical services, covering government-subsidised inpatient and outpatient services. The hospital will also undertake key missions in training and education, research, collaboration and creating health values, including offering clinical internships to students of the three local universities with Schools of Chinese Medicine and serving as a clinical training platform for CM practitioners.
