## Record high numbers of companies and start-ups affirm Hong Kong's increasing attractiveness to businesses

According to the results of the 2024 Annual Survey of Companies in Hong Kong with Parent Companies Located outside Hong Kong (2024 Annual Survey) and the 2024 Startup Survey, released by the Hong Kong Special Administrative Region (HKSAR) Government on December 17, the number of companies in Hong Kong with overseas or Mainland parent companies, as well as start-ups, reached record highs.

According to the 2024 Annual Survey jointly conducted by Invest Hong Kong (InvestHK) and the Census and Statistics Department (CSD) of the HKSAR Government, there were 9 960 companies in Hong Kong with parent companies located outside Hong Kong in 2024, representing an increase of 10 per cent when compared with that of last year. The number of people employed reached 493 000, recording an increase of five per cent year on year.

Analysed by major line of business in Hong Kong in 2024, among those 9 960 companies, the import/export trade, wholesale and retail sector topped the list, followed by the financing and banking sector and the professional, business and education services sectors.

In addition, according to the results of InvestHK's 2024 Startup Survey, start-ups in Hong Kong continued to flourish with a record high number of 4 694, up by 10 per cent from last year, fully illustrating the attractiveness of Hong Kong to start-up founders. These start-ups spanned across different sectors, such as financial technology; information, computer and technology; electronic commerce; education and learning; and data analytics, etc. Notably, the number of start-ups in the health and medical sector as well as the sustainable technology/green technology sector recorded significant year-on-year increases of 54 per cent and 82 per cent respectively.

# Expansion of one-stop dataset of physical banking facilities of retail banks in Hong Kong

The Hong Kong Monetary Authority (HKMA) announced on December 9 that an additional spatial dataset is made available via Open Application Programming Interface (API) for public use. The relevant datasets are available for download from the HKMA's Open API portal.

The new dataset provides information on five types of self-service banking machines of 20 retail banks in Hong Kong, covering cash deposit machines, cheque deposit machines, integrated cash and cheque deposit machines, passbook update machines, as well as video teller machines. Together with the two datasets launched last year, the HKMA's website now provides a total of three one-stop datasets of physical banking facilities of retail banks.

Furthermore, the two existing datasets of physical branches and Automated Teller Machines (ATMs) have also been enriched with more information to make the database more comprehensive, such as the availability of barrier-free measures at branches as well as the currencies available for deposit and withdrawal through the ATMs.

# Immigration Department introduces self-application services for Hong Kong identity cards

The Immigration Department of the HKSAR Government on December 12 announced that the services of the Personal Documentation Submission Kiosks (PDSKs) have been enhanced by introducing self-application services for Hong Kong identity cards (HKICs).

Eligible applicants can complete the HKIC application procedures in a self-service manner and can apply for HKICs and HKSAR passports in one go through the PDSKs. The new services will further automate and digitalise the application and collection procedures for personal documentation, thereby providing more convenient services to members of the public.

The PDSKs are set up at the Immigration Headquarters in Tseung Kwan O. Eligible applicants can complete the application procedures, including electronic form filling and signing, photo taking, fingerprints taking and application submission, at the PDSKs in a self-service manner. The services provided by the PDSKs are appointment-free.

#### International study shows Hong Kong students' outstanding performance in mathematics and science

The results of the Trends in International Mathematics and Science Study (TIMSS) 2023 were announced on December 4. The overall performance of Hong Kong students far exceeded the international average, showcasing their outstanding achievements.

Hong Kong students maintained a consistently high level of performance in mathematics. The Primary Four (P4) students ranked fourth with a score of 594, which significantly surpassed the international average of 503. The Secondary Two (S2) students maintained the fifth place with a score of 575, notably exceeding the international average of 478.

Significant progress was also seen among Hong Kong students in science, with P4 and S2 students showing a marked rise from 15th and 17th in the previous cycle to ninth and eighth in this cycle, scoring 545 and 528 respectively, significantly surpassing the international average of 494 and 478.

#### Hong Kong team achieves excellent results at International Junior Science **Olympiad**

A team of six students representing Hong Kong achieved outstanding results in the 21st International Junior Science Olympiad (IJSO 2024), winning a total of two gold and four silver medals.

The IJSO is a science competition for secondary students aged 15 or below. The competition, covering physics, chemistry and biology up to the senior secondary level, comprises written assessments and science experiments that require students to analyse and solve unfamiliar problems. The IJSO 2024 was held in Romania from December 2 to 12 with the participation of around 300 contestants from 52 countries or regions.

# Import of poultry meat and products from Rural Municipality of Portage la Prairie of Manitoba Province in Canada suspended

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department of the HKSAR Government announced on December 9 that in view of a notification from the World Organisation for Animal Health about an outbreak of highly pathogenic H5N1 avian influenza in the Rural Municipality of Portage la Prairie of Manitoba Province in Canada, the CFS has instructed the trade to suspend the import of poultry meat and products (including poultry eggs) from the area with immediate effect to protect public health in Hong Kong.

Hong Kong imported about 370 tonnes of frozen poultry meat from Canada in the first nine months of this year.
